RELEASE, WAIVER AND ASSUMPTION OF LIABILITY
PLEASE READ CAREFULLY

I am aware that riding off-road vehicles, and paintball activities, including but not limited to, motorcycles, go-carts, paintball guns, markers, and all-terrain vehicles may pose potentially serious risks of injuries or even death to the rider and/or passenger and/or spectator. I understand that I may be injured or die as a result of my negligence, the negligence of others, or through no fault of mine or anyone else, because of the nature of the activity in which I am going to be engaged.

With this waiver, I expressly assume risk of injury or death in connection with participating in any events for any reason, including but not limited to negligence of Hills Plaza, L.L.C., South Fork MX, L.C., South Fork MX Club, VMP MX, L.C., Extreme Factory MX, L.C., its agents, employees, officers, members, club members and directors (hereinafter called "Hills Plaza").

With the knowledge of the foregoing, and as an inducement for Hills Plaza to allow me to participate, ride and play on its land, track, and/or paintball area. I hereby agree to waive or release any and all rights that I or my heirs may have to make a claim against Hills Plaza and other participants, or any landowners over whose land I ride, arising from any damages, injury, or death which I might sustain or any damages which might occur to my off-road vehicle or paintball equipment. I further agree to indemnify and hold harmless all of the foregoing from any claims which I might make or which might be made on my behalf by others or which might be made against me by others, arising from my participation on and around the track and/or paintball area against Hills Plaza and other participants, or any landowners over whose land I ride and play. Furthermore, I agree to indemnify Hills Plaza and other participants, or any landowners, their families, employees or tenants, for any injury, death, or loss or damage to any personal property which might occur during riding or playing on or around the track, when such injury, death, loss or damage occurs on the property of the landowner.

BY SIGNING THIS WAIVER AND RELEASE, I UNDERSTAND THAT I AM GIVING UP, (WAIVING AND RELEASING) ANY RIGHT I MIGHT HAVE TO SUE OR MAKE A CLAIM WHICH I MIGHT HAVE OR WHICH MIGHT SUBSEQUENTLY ARISE OR OCCUR AGAINST HILLS PLAZA AND OTHER PARTICIPANTS, AND/OR ANY LANDOWNERS, THEIR FAMILIES, EMPLOYEES OR TENANTS, OVER WHOSE LAND I RIDE AND PLAY, FOR INJURING ANYONE ELSE OR ANY OFF-ROAD VEHICLE RIDDEN BY ANOTHER WHILE SO ENGAGED. IT IS MY INTENT TO GIVE UP THOSE RIGHTS AND PROVIDE THIS HOLD HARMLESS AGREEMENT, AND I DO TO KNOWINGLY AND VOLUNTARILY. I UNDERSTAND THERE ARE NO FLAGGERS AND NO MEDICAL SERVICE PROVIDED BY HILLS PLAZA.
